- Working with suppliers to reduce environmental impacts across product lifecycles
- Supporting customer requests for environmental and Scope 3 / WLCA data on a best-available basis

Environmental performance is reviewed regularly as part of our ISO management systems.

Connexion Developments Ltd conducts all business activities with integrity, fairness, and professionalism.

We are committed to:

- Zero tolerance of bribery, corruption, or unethical behaviour
- Compliance with all applicable UK and international laws and regulations
- Transparent and honest communication with customers and partners
- Fair competition and responsible marketing practices

This commitment is supported by our Anti-Bribery, Anti-Corruption, and Code of Conduct policies.

## 6. Responsible Supply-Chain Management

Responsibility for this CSR Policy rests with company directors and senior management.


We commit to:
