



## CE, RoHS, REACH and WEEE Regulation Compliance Statement

### ROHS Directive - Restricted Substances as per Article 4(1), Annex II

The Restriction of Hazardous Substances (RoHS) Directive regulates the use of specific hazardous materials in electrical and electronic equipment (EEE) placed on the European Union market. Initially introduced as Directive 2002/95/EC, RoHS has been in effect since July 1, 2006. It applies to all relevant products sold in the EU.

The directive was updated by Directive 2011/65/EU (RoHS 2), which expanded its scope to include CE marking requirements, additional product categories (8 and 9), and stricter documentation and compliance obligations. Further updates came with Directive 2015/863 (RoHS 3), which added four phthalates to the restricted substances list.

Currently restricted substances, along with their maximum concentration values in homogeneous materials, are as follows:

- **Cadmium (Cd):** < 100 ppm
- **Lead (Pb), Mercury (Hg), Hexavalent Chromium (Cr VI), Polybrominated Biphenyls (PBB), Polybrominated Diphenyl Ethers (PBDE):** < 1000 ppm
- **Bis(2-Ethylhexyl) Phthalate (DEHP), Benzyl Butyl Phthalate (BBP), Dibutyl Phthalate (DBP), Diisobutyl Phthalate (DIBP):** < 1000 ppm

### WEEE Regulation Directive 2012/19/EU - 2012/95/EC.

The Waste Electrical and Electronic Equipment (WEEE) Directive regulates the recycling and treatment of electronic waste. Initially transposed into UK law through the WEEE Regulations 2006, these regulations were updated and replaced by the Waste Electrical and Electronic Equipment Regulations 2013, which came into force on January 1, 2014.

The 2013 Regulations implement the provisions of Directive 2012/19/EU, expanding the scope to include additional product categories and establishing requirements for the collection, recovery, reuse, recycling, and disposal of WEEE. As of January 1, 2019, the scope of these regulations was further extended. Connexion Developments Ltd. acknowledges its responsibilities under the WEEE Directive, ensuring compliance in product design and facilitating appropriate collection, treatment, and recovery processes. ### REACH Regulation (EC) 1907/2006

The REACH Regulation (EC) 1907/2006, which stands for Registration, Evaluation, Authorisation, and Restriction of Chemicals, is an essential piece of EU legislation. On June 25, 2020, the European Chemicals Agency's Member States Committee (MSC) added lead to the Candidate List of Substances of Very High Concern (SVHC), bringing the total number of SVHCs to 247.

Under the European Union (Withdrawal) Act 2018, the EU REACH Regulation was incorporated into UK law as UK REACH on January 1, 2021. This

transition retained the core principles of EU REACH, with necessary adjustments for domestic application. The relevant REACH Statutory Instruments can be accessed at [legislation.gov.uk](https://legislation.gov.uk).

Connexion Developments Ltd. certifies that, to the best of its knowledge, all products supplied do not contain any substances listed on the SVHC Candidate List (as of June 25, 2020) at concentrations exceeding 0.1% by weight. ### CE compliance EU safety, health, and environmental requirements.

CE Compliance refers to adherence to the EU's safety, health, and environmental standards. The CE mark is mandatory for products sold within the European Economic Area (EEA), signaling that the manufacturer or importer (if outside the EU) has ensured the product meets these requirements. ### UKCA compliance UK safety, health, and environmental requirements.

The UK government has enacted legislation to maintain recognition of existing EU requirements, including the CE marking (Conformité Européenne), for a range of product regulations. This legislation will remain in effect indefinitely. The UKCA (UK Conformity Assessed) marking is valid until 31st December 2024.

### Validation Method.

Connexion Developments Ltd. ensures compliance with RoHS, REACH, WEEE, and CE regulations by collecting and verifying declaration statements, letters, and certificates from manufacturers and suppliers. This process ensures that all supplied products meet the relevant regulatory standards.
