Protecting our Environment:

As part of our ongoing commitment to reduced waste and the impacts upon the environment, it is company policy to recycle as much and consume as little as possible.

Boxes – 98% reused – damaged or unusable boxes are recycled.

Paper – 100% recycled – recycling bin.

Pallets: Reused or returned to delivery driver - broken / damaged wooden pallets are recycled.

Metals: 100% recycled

Ink cartridges: No longer used, we now use ink tank ecofriendly printers, reduced costs + packaging.

Lighting: Now all 100% LED low power.

Office Equipment: 100% recycled any hard drive data erased by formatting. No Card data stored as per PCI compliance.

Water usage: 2022 to 2023 now reduced by 24% by installing ecofriendly toilets and self-closing taps.

Plastics: suppliers advised to reduce plastic packaging as much as reasonably possible.

Carbon footprint: 50% stock increase via sea cargo shipments reduce air cargo requirements, environmental impact + costs.
